## Ensuring Fiscal Stability/Responsibility

\*The Budget Cycle, regular review \*Multi-Year Projections (3 year requirement) \*Reserve for Economic Uncertainties

Expenditures: Benefits: 25%

Supplies: 8% Services: 11% Salaries: 54% Other: 2%

Revenues: LCFF: 81% (Local Control Funding Formula)\* Federal Revenue: 3% State Revenue: 7% Local Revenue: 9%

\* LCFF is based on ADA, COLA, Supplemental Grant based on the number of targeted pupils.

Hart District is receiving \$13,000,000 to go towards unduplicated students ( Low SEL, ELL, homeless/foster youth)

#### RESTRICTED VS. UNRESTRICTED FUNDS:

Restricted funds are granted to Districts for a *specific* purpose.

- Title I Improving Academic Achievement
- Prop 28 Arts and Music in Schools
- CA School Employee Summer Assistance Program (CSESAP)
- Special Education

Over 25% of our Ending Fund Balance (EFB) is Restricted
